The legislative engagement policy was approved by the OGP Steering Committee in September 2016. This marked a significant step for OGP in moving away from the executive branch engagement solely to other branches. Since then, more parliaments have joined the OGP platform and developed commitments under the National Action Plans. The aim of the session is to discuss challenges and opportunities the policy has brought about, as well as share good practices for parliamentary engagement in OGP.
